Each bidder within given time, dropped respective bid into bid box placed in SDMA office. Bid opening was conducted in the SDMA office on 20th June 2024. The bidder's representatives attended the bid opening event: attendance sheet is enclosed. Envelopes were found firmly sealed. The name of bidder and presence requisite bid security were announced. The quoted price for each Lot as shown below were read out aloud. Transparent tape was affixed right at the quoted price amounts. Procurement Committee appended signatures on the important quotation papers. (The bid submission event was recorded in videos).

The second round of evaluation process was carried out on 08th July 2024 to examine/evaluate the samples of each Lot according to the specification enshrined in the bidding documents. The bid and samples of each bidder thoroughly examined in accordance with the qualification requirements of bidding documents.

Conclusion /Recommendation:

Lot-I

For the Lot-I the bid of the first lowest bidder i.e **Pearl Associate** found responsive and sample provided for each items in Lot-I are found according to the specification/qualification requirement of bidding conditions. Hence the committee recommends award of contract for the Lot-I in favor of **M/s Pearl Associate Manufacturer and General Order Supplier Plot No 295 Street No. 27 Sector F-11/2 Islamabad Pakistan.**

Note: During the evaluation/scrutiny process a discrepancy found in the Sum Total of Item No. 4 i.e Kitchen Set of Lot-I in the bid quoted by Active Vision (Pvt) Ltd. The unit price of Kitchen Set is quoted Rs. 4940/-. The sum total for 1000 Kitchen sets should come Rs. 4940000/- while in the bid, sum total of this item is written as Rs. 494000/- which is incorrect. Hence the correct total price of Lot-I quoted by M/s Active Vision (Pvt) Ltd is Rs. 15027500/-

Lot-II

For the Lot-II the bid of the first lowest bidder i.e **M/s Active Vision (Pvt) Ltd** found responsive and sample provided for each items in Lot-II are found according to the specification/qualification requirement of bidding conditions. Hence the committee recommends award of contract for the Lot-II in favor of **M/s Active Vision (Pvt) Ltd Plot # 111, Main Sumbal Road, Sector F-10/I Islamabad, Pakistan**
