- ii) The quoted rates of some items are significantly higher than the prevailing market rates, while the rates of some other items are abnormally low. This indicates an imbalance in pricing and does not reflect fair and realistic market values. Therefore, the bid is considered non-responsive and is rejected due to abnormal and imbalanced pricing

11. Recommendations/ Decision;

As per the evaluation of the bids and for the above-mentioned reasons, in accordance with Rule 33 of the AJKPPRA Rules, 2017, the Central Purchase Committee unanimously rejected all the bids. Furthermore, under Rule 34 of the AJKPPRA Rules, 2017, the Committee recommended re-bidding.
