**Bidding is open to all eligible Bidders**

- i. The Executive Engineer Highways Division Neelum on behalf of the Employer, invites sealed bids under **AJKPPRA Rules 36(a) Single Stage-One Envelope Procedure**, from eligible firms or constructors licensed by the Pakistan Engineering Council (PEC) and duly endorsed by Chief Engineer Highways North/South Public Works Department AJK in the appropriate category with field of specialization as mentioned in column No.4&5 for the above work(s).
- ii. The bidders are required to submit their bids in accordance with the clause 29 of the AJK PPRA Rules.
- iii. A complete set of bidding documents may be purchased by an interested bidder on submission of the following on or before **03-10-2019** during the office hours.
  - a. Payment of a non-refundable tender fee as mentioned in Column No.6
  - b. Submission of Bid security in form of CDR as mentioned in Column No.7. The CDR must be issued in favor of the Executive Engineer PWD Highways Division Neelum by a schedule Bank in Pakistan having its branches in Azad Kashmir. Open CDR'S will not be accepted.
- iv. The application must be accompanied by a declaration/affidavit that he or its firm is not black listed by any of the departments/ministries. Bidding documents will not be issued without this declaration/affidavit.
- v. Tender Documents will be issued only to constructor(s)/firm(s) or their authorized representative(s) who will show original power of attorney along with original authority letter on stamp paper of Rs.100/-
- vi. All CDRs except successful bidder will be released after the verification from bank and as per procedure laid down in the bidding documents.
- vii. The bidder should quote rates in "**percentage above/below on the basis of AJKCSR**" and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.
- viii. In case the amount of bid offered is less than the estimated cost by 10 % or more than 10 % , the bidder shall provide with the bid additional performance security in the shape of CDR issued by a Schedule Bank in Pakistan having its branches in Azad Kashmir, equal to the amount of difference between the Estimated Cost and the Bid Cost. Failure to provide the said additional performance security with the bid, the bid shall be considered as non-responsive and rejected.
- ix. Bid must be delivered at the office of under signed on **04-10-2019** before 11:00 A.M. Bids will be opened on **04-10-2019** at 11:30 A.M. by the bid opening committee in the presence of bidder(s) or their representative(s) who can show proof of submission of Bids (receipts). Conditional, incomplete and bids filled with led pencil will not be acceptable.
- x. The employer reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
