The Employer invites sealed bids, under Single Stage-Two Envelope bidding procedure, from eligible firms or persons licensed by the Pakistan Engineering Council in the category C-1 and above renewed for current year with PEC specialization code CE-10, ME01, ME02, ME03, EE01, EE02, EE03, EE04 for the Works. A foreign bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the relevant provisions of PEC bye-laws and must be registered with PEC and be endorsed by the Employer.

 Quoted Rate (CQR). Bidder has to write his bid in tender form both in figures up to 2 decimals (only two digits
 after decimal will be considered) and in words.
