Tender/Bids complete in all respects should reach on or before 10th March, 2023 till 11:00am in the office of the Secretary Relief, Disaster Management & Civil Defence Block No. 10 New Secretariat, Chatter Muzaffarabad Azad Kashmir, which shall be opened on the same day at 11:30am by Committee in the presence of Bidders or their authorized representatives who opt to attend the meeting.

TERMS & CONDITIONS: -

- 1. The bidding document contains detailed specifications, instructions and conditions for those who intend to participate in the bidding process and all interested manufacturers / firms/ suppliers/ authorized dealers are earnestly advised to read the bidding document before submission of their proposals / Bids which can be obtained in lieu of a non-refundable cash payment of RS. 1000/- from the office of Director State Disaster Management Authority, Block No. 10 New Secretariat ,Chatter Muzaffarabad Azad Kashmir, on or before 10th March, 2023 till 10:45am.
- 2. Black listed Firms/Companies/Suppliers/Contractors/Bidders are not eligible to participate in bidding process and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.

Call deposit receipt of an amount equal to 3% of the total quoted value in favor of Deputy Director Ops SDMA Muzaffarabad Azad Kashmir should accompany every quotation otherwise the offer will not be entertained.

- 4. Bid prices must be quoted on the relevant page of bidding document i.e. price schedule for the material to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
- 5. Pre delivery inspection will be carried out before taking over the ordered items.
- 6. Quoted price of the offered items should include all applicable taxes in AJ&K.
- 7. The successful bidders shall be bound to construct/erect the shelters within 45 days from the date of issuance of work order.
- 8. Pre-Fabricated Shelters will be delivered and erected to the respective locations mentioned in bidding document.
- 9. Brochures and samples of sandwich panels containing technical data shall be furnished along with the bids.
- 10. The Procuring Agency may reject all Bids or proposals at any time prior to the acceptance of a Bid or proposal.
