
**TENDER NOTICE**

- Rates should be quoted exclusive of General Sales Tax on Free Consignee store (FCS) AK basis.
- Conditional bids/tenders will not be entertained.
- Validity of rates should not be less than 120 days from the date of bid/tender opening.
- For **category M-5 samples must be provided** by the firms along with the bids at the time of bids opening otherwise, Offer shall not be entertained.
- All terms and condition governing this tender are mentioned in the tender/bidding document (ready for purchase) which can be purchased up to **13-06-2023** from this office (Chief Engineer Electricity Mirpur) during office hours against cash payment of **Rs. 400/- each**.
- Income Tax, Tajweed-ul-Quran Trust funds, Stamps Duty and all other duties/taxes applicable in AJ&K at prevailing rates shall be deducted from the bills of successful bidders at source.
- Black listed firms/ companies/ suppliers/ distributors / contractors / bidders or prohibited for participation. All bidders shall furnish neither on affidavit / certificate that they are neither black listed nor in conflict with the government anywhere in territory of the state of AJK, federally administrated areas or Islamic republic of Pakistan.
- Evaluation report / award of contract shall also be displayed at AJK PPRA web site.
- Category / name of items must be clearly written on the envelop.
- The competent Authority (DPC-I) shall reserve the right to accept or reject all or any bid/tender as per AJK PPRA Rules 2017.
