The Azad Jammu & Kashmir Electricity Department (AJKED) invites sealed bids for Supply, Installation, Testing, Commissioning and Support Services for CIR (**Uncompressed & Unshared**) Connectivity from the eligible firms registered with Income Tax and Sales Tax Department and who are on active Taxpayer List.

Terms and conditions:

1. AJK PPRA rules "open competitive bidding using **single stage-one envelop procedure**" will be followed in the procurement process.
2. Bid security (Call Deposit receipt, demand draft, pay order, Bank Guarantee) for fixed amount of rupees to Rs. 300000/- of the tender value in favour of Director General Commercial Electricity Muzaffarabad should accompany every tender. Validity of the bid security should not be less than 150 days from the date of opening of tenders.
3. Validity of rates should not be less than 120 days from the date of tender opening.
4. All terms and conditions, detail of items to be purchased governing this tender are mentioned in the tender documents which can be obtained up to **06-07-2023** from the office of the Director General Commercial Electricity Muzaffarabad within office hours on written request and upon payment of Rs. 1000/- in cash (Non-refundable).
5. Rates should be quoted inclusive of General Sales Tax and all other prevailing taxes in AJK on ex-consignee store Muzaffarabad, Rawalakot, Kotli and Mirpur with installation and support services.
6. Incomplete/conditional bid and bid bearing cutting/over writing without authentication will not be considered.
7. The bids prepared in accordance with the instructions of the bidding document must reach at the office of the undersigned on or before **10:00 AM** dated **07-07-2023**; Bids will be opened on the same day at **10:30 AM** in presence of Bidders' representative(s) who choose to attend.
8. The bidder must submit an authority letter in the name of his representative, if his representative participated in the bidding process on his behalf.
9. Bandwidth mentioned above can be increased or decreased by AJK-PPRA Rules, 2017.
10. "Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of AJK, federally administrated areas or Islamic Republic of Pakistan.
11. The Competent Authority reserves the right to accept or reject all or any tender as per AJK-PPRA Rules, 2017.
