**TERMS AND CONDITIONS**

- i. Bidding is open to all the eligible bidders having financial soundness and may obtain further information, inspect the wood lots on relevant sites and acquire Bidding Document from the office of the *Divisional Forest Officer Utilization Division, Office at Rasheedabad near Quaid-e-Azam Bridge Domail Muzaffarabad Ph. # 05822-921683.*
- ii. A complete set of Bidding Document may be purchased till 02-08-2023 3:50 PM by an interested bidder on the submission of a written application and upon payment of a non-refundable fee of @Rs.1000/- from the office of the *Divisional Forest Officer Utilization Division, Office at Rasheedabad near Quaid-e-Azam Bridge Domail Muzaffarabad Ph. # 05822-921683.* The department will allow and facilitate to inspect any are all wood lots up to one day before tender opening. Separate list of all wood lots, packages, and species/classification as given in the bidding document will be provided to all eligible Bidders.
- iii. Bidding Documents and Forms will be issued only to eligible bidders or their authorized representative upon the furnishing of application along with the power of attorney/ authority letter on stamp paper of Rs.100/- duly attested by oath commissioner by the bidder along with attested copies of CNIC.
- iv. The interested bidders shall submit in the shape of CDR an amount of bid security as indicated in the above given table separately for each package in the name of **Divisional Forest Officer Utilization Division Muzaffarabad.**
- v. All bids must be delivered to the office of the **Divisional Forest Officer Utilization Division Muzaffarabad** at or before **1:30 PM on 07-08-2023.** The bids will be opened



at 2:00 PM on the same day, in the presence of bidders or their representative(s) who choose to attend at the same address. Only the responsive bids having sound proposals will be considered.

- vi. The bidder must ensure that they may submit all the required documents indicated in the Bidding Documents/ Bidding Data Sheet.
- vii. Successful Bidder as per depot sale & rule No.26 will have to pay at least 10% of the total amount offered as advance at the time of tender openings.
- viii. The successful bidder will be allowed to transport and sale wood any where in AJK & Pakistan.
- ix. According to Forest Law, depot and sale rules section No.26, the successful bidder is bound to pay remaining amount in Government treasury within 60 days after issuance of the work order. An extension of 20 days will be allowed after payment of 02% fine, while further 25 days may be extended with an extra fine of 03%. So the successful bidder will have to pay all the offered amount within 105 days.
- x. According to Forest Law depot and sale rules section No.27 if the remaining amount is not paid within due time, the deposited 10% amount together with the amount of the call deposit will be forfeited in favor of AJK Government. All sale of timber be cancelled and the ownership will rest to the government. Any mark on the sale timber of successful bidder will be abolished and the timber may be treated as (not sold lots).
- xi. According to Forest Law depots and sale rules section No.29 the successful bidder is bound to handover the sale timber within 90 days after issuance of work order. After this period the bidder will have to pay/paisa/CFT/day as a rent amount.
- xii. The Bidders are bound to offer the prices of whole package separately, wood lots, rate per CFT with whole calculated amount.
- xiii. All government taxes including advance tax, sale tax, etc. will be paid by the successful bidder.
- xiv. All the submitted bids will be scrutinized by AJK PPRA Rules 2017, 2022 and Forest Law depot and sale rules with all other amendments together with all rules, regulations and acts of Forest Department and Go AJK.
- xv. The Bid of the any are all bidders may be rejected as of Rule No. 33 of AJK PPRA Rules 2017.
