- Hard copy of Original Bid Security and Bidding Documents (Signed and stamped) must be submitted in the office of the Executive Engineer PWD Highways Division Kotli within 48 hours after opening of bid through E-Bidding system.
- Bidders who submit their bids without a valid call deposit will be debarred from participating in bidding process for one year.
- The bid securities of unsuccessful bidders will be returned upon award of the contract to the successful bidder or on the expiry of validity of bid, whichever is earlier.
- 9 Electronic Bidding shall be done on percentage (Above/Below) Basis. Only Two digits after the decimal point shall be considered for evaluation purpose.
- "Blacklisted Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation" and all bidders shall furnish an affidavit/certificate that they are neither blacklisted nor in conflict with Govt. anywhere in territory of the state of AJK, federally administrated areas or Islamic Republic of Pakistan.
- Electronic Bids will be displayed through online E-Bidding system after 30 Minutes of closing time in the presence of bidders/ their representative who choose be present.
- 12 Any Bidder(s) who provides incorrect information shall stand disqualified as per PPRA Rules.
- The competent authority reserves the right to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
