Communication & Works Department "Highways Division Bagh" Govt. of Azad Jammu & Kashmir invites Electronic Bids in accordance within AJK PPRA Rules 36(b) Single Stage-One Envelope Bidding Procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year, 2022-23 and endorsement in PWD AJ&K department in appropriate category mentioned against each work in column 5 below **with Specialization Code CE-10** for the following works. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval by the Employer for bidding as joint venture.

- 1 Bidders/Firms which are registered with C&W Department Eligible for E-Bidding.
- 2 Prospective bidders are required to get user name and log in detail from IT Section, Office of The Chief Engineer Highway (North) Block H, DHQ Muzaffarabad. Bidders/Firms which are already electronically registered with the Department can use already provide user name & Log in.
- 3 Bidding Documents and instructions to Bidders can be downloaded up to one day prior to the opening date from C&W website(www.cwd.ajk.gov.pk)
- 4 Bidders who submit their financial bids without a valid call deposit will be debarred from participating in bidding process for one year.
- 5 The bid securities of unsuccessful bidders will be returned upon award of the contract to the successful bidder or on the expiry of validity of bid, whichever is earlier.
- 6 Electronic Bidding shall be done on **percentage (Above/Below) Basis** on. Only Two digits after the decimal point shall be considered for evaluation purpose.
- 7 "Black Listed Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation" and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Govt. anywhere in territory of the state of AJK, federally administrated areas or Islamic Republic of Pakistan.
- 8 Electronic Bids will be displayed through online E-Bidding system after 30 Minutes of closing time in the presence of bidders/their representatives who choose to be present.



- 9 Any Bidder (s) Which provides incorrect information shall stand disqualified as per PPRA Rules.
10 The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.


