NOTICE INVITING E-BIDDING
(UNDER SINGLE STAGE ONE ENVELOPE E-BIDDING SYSTEM)

The Development Authority Muzaffarabad invites Electronic Bids in accordance with AJK PPR Rules 36(a) Single Stage-One Envelope bidding procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year, 2023-24 and having endorsement in AJK PWD as well as Development Authority Muzaffarabad AJ&K department in appropriate category mentioned against each work in **column V below with relevant Specialization Code** for the following works. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.


Bidding is open to all Eligible Bidders

- Bidding is open to all Eligible Bidders / Firms which are registered with C&W Department for E-bidding.
- Prospective bidders are required to get Username and Login details from IT section, Office of Chief Engineer Highways (North), Block H, DHQ Muzaffarabad. Bidders / Firms which are already electronically registered with the department can use already provided Username and Login.
- Bidding documents and instruction to bidders can be downloaded prior to the specified opening date from C&W web site. (www.cwd.ajk.gov.pk)
- Interested bidder are required to submit their Electronic Bid up to **12:00 PM 05th October 2023**, The bid will be open on **same day & same time** through E-Bidding process and comparative Statement will be visible to the Participant Bidders & Bid Opening Committee for further process. The venue for E-Bidding is Committee Room **N-Block, DHQ Muzaffarabad**.
- Scanned copy of Bid Security (CDR) must be uploaded, and Hard Copy of Original Bid Security and Bidding Documents (Signed and Stamped) must be submitted in the office of the Executive Engineer Development Authority Muzaffarabad on the next day i.e on 06th October 2023 after opening of Bid through E-Bidding System.
- Bidders who submitted their bids without a valid call deposit will be debarred from participating in bidding process for one year.
- The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
- Electronic bidding shall be done on **Percentage (above/below) basis** only two digits after the decimal point shall be considered for evaluation purpose.

9. "Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
10. Any bidder (s) which provides incorrect information shall stand disqualified as per AJK-PPRA Rules.
11. The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
