

## INVITATION FOR BIDS

District Livestock & Poultry Development Officer Kotli Azad Jammu and Kashmir intends procurement of poultry feed for the financial year 2023-24 for District Kotli from well reputed income tax registered companies as enclosed subject by following terms and conditions:

- 1 Bidding shall be conducted through "Open Competitive Bidding" according to the "Single Stage –one envelope" procedure Specified in the AJ&K PPRA Rules 2017, 6(36). "Financial bid" and "Technical Bid" should be mentioned on the envelopes otherwise tender will be rejected. Technical bids will be opened first. Financial bid of only technically qualified Bidder will be opened.
- 2 Sealed Bids must be delivered to above office at given mailing address/location on or before 12:00 PM on 06\_10\_2023.
- 3 The bidder will have to provide a Bids Security @ 150000/- of Bid Value in the form of CDR From a Scheduled Bank of Pakistan in favor District Livestock & Poultry Development Officer Kotli. The bidder may be asked to provide performance guarantee rate of 5% of contract amount.
- 4 Bids will be opened in the presence of bidders of their representative who choose to attend (along with Authority Letter) at 2:00 PM in the District Livestock and poultry development office Kotli on the same date.
- 5 The Bidders are required to submit their best and final prices matching to the "Principal of Value For money" meaning Quality Products.
- 6 The quoted price shall be applicable for the whole financial year 2023-24.
- 7 The Bidder/Supplier having the experience of at least two years with good performance certificate from procuring agency in the relevant field of poultry supply will be preferred.
- 8 *The Bidder/ Suppliers must have their office and feed store at Kotli.*
- 9 Taxes will be deducted as per applicable under AJ&K Tax Laws and Government rules from amount billed for.
- 10 Specification of items with bidding from annexed here with the advertisement notice for further classification meant for Bid Submissions or best value /price quotations.
- 11 Black Listed firms /Companies /Supplier /Distributors /Contractors /Bidders are prohibited for participation and all bidders shall furnish an affidavit /certificate on the Judicial stamp paper that they are neither black listed nor in Conflict with Government anywhere in territory of the state of AJ&K , Federally administrated Areas or Islamic Republic of Pakistan.
