- 3 Bidding will be done on "MRS,2nd BI-Annual-2023(01-07-2023 to 31-12-2023) District Murree., on percentage (above/below) basis. Contractor has to Quote the rates of Bid price in words and in digits and only two digits after decimal will be considered.
- 4 Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend the following address. Incomplete and bids filled with led pencil will not be acceptable.
- 5 Serial No 1 and other serial Nos. will be consecutively open after interval of 15 minutes each.
