TERMS & CONDITIONS: -

1. The bidding document contains detailed specifications instructions and conditions for those who intend to participate in the bidding process and all Interested manufacturers / firms / importers / bidders / suppliers/ authorized dealers are earnestly advised to read the bidding document before submission of their proposals / Bids which can be obtained against the bidding documents for a non-refundable cash payment of Rs. 2500/- (non-refundable) from the office of Director State Disaster Management Authority, Block No. 10 New Secretariat, Chatter Muzaffarabad Azad Kashmir, on or before 05th December, 2023 during the office hours by submitting a written request on the firm/company letter head.
2. Black listed Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
3. Financial guarantee from insurance companies shall not be accepted.
4. Call deposit receipt of Rupees 2000000/- should be submitted in favor of **Deputy Director Admin SDMA Muzaffarabad Azad Kashmir**, rates offered without CDR, Pay order will not be entertained.
5. Bid prices must be quoted on the relevant page of bidding document i.e. price schedule for the items to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
6. Pre delivery inspection will be carried out before taking over the ordered items.
7. Quoted price of the offered items should include all enforced applicable taxes vogue in AJ&K.
8. The successful bidders shall be bound to supply the ordered items within 90 days from the date of issuance of work order.
9. Incomplete and conditional offers shall not be entertained.
10. Brochures/Samples of the quoted equipment's shall be furnished along with the bids.
11. In case of foreign bidders, bid document will be issued/accepted through their approved representatives/agents or distributors in Pakistan holding authority from their Principals for obtaining the documents and participating in bids.
12. Foreign bidders and manufacturers of goods for which local bidders quote must possess sufficient experience in performance and marketing. The successful bidders will be bound to submit a performance security/bond equal to 10% of the contract price within 10 (Ten) days after being declared successful bidder for award of supply contract.
13. The competent authority reserves the right to accept or reject any quotation in part or full assigning any reason therefore.
