Financial Proposal of bids found technically non-responsive shall be returned to the respective bidders
2. Procurement of consumables / kits for ELISA Eti Max 3000 & CLIA or equal lent & compatible all manufactures/ authorized Importers and authorized distributors can participate.
3. Bid Security (CDR) @ 59000/= of total bid value in the name of Deputy Director, AJK Central BTS/Regional Blood Center (RBC) Muzaffarabad must be accompanied with the Financial Bid and copy attached with Technical bid. Cheque shall not be accepted.

6. All taxes / duties levied by GoAJK will be charged from the bills under admissible rules.
7. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.

The bidder shall submit an affidavit on legal stamp paper of Rs. 100/- that their firm has not been blacklisted in the past on any ground by any Government (Federal, Provincial and AJ&K), a local body or a public sector organization. On account of submission of false statement the bidder shall be disqualified forthwith and subsequently black listed.
