The bids will be opened on same day at 12:30 pm, in presence of bidders or their nominated agents present there at. No tender document will be sold after 09<sup>th</sup> **January 2024**.

- 1. The firms should be registered with sales tax/ CBR/income tax department.
- Taxes will be deducted as per applicable under AJ&K Tax Laws & Government Rules from amount billed.
- Departmental Purchase Committee reserves the right to reject all bids proposals at any time according to AJ&KPPRA Rules 2017.
- 4. The Departmental Purchase Committee shall upon request communicate to any supplier or contractor who submit a bid or proposal, the grounds for its rejection of bids or proposal, but is not required to justify those grounds.
- The Departmental Purchase Committee may decrease or increase the quantity as per AJ&K PPRA Rules 2017.

- Successful bidders has to deliver Items within 60 days after issuance from award of procurement contract.
- 7. The Bidders have to deposit their samples (where applicable) at the time of opening the tenders. Otherwise the offers shall be ignored.
- 8. Blacklisted Manufacturer/ Firms/Companies/Suppliers/Distributors/Contractors/Bidders prohibited for participation "and All Bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Government anywhere in territory of the state of the AJK, federally administrated Areas or Islamic Republic of Pakistan.

Single stage Single envelope bidding procedure shall be applied. The call deposit/ Earnest Money (Refundable)Rs:8,00,000/- in the form of CDR in favor of **DDO Central Police**Office Muzaffarabad, is required to be submitted with the Bid, proposal without which the offer shall be rejected being non-responsive.

**Note:** All assessments and procuring procedure i.e. receiving, opening and awarding contract etc. shall be governed by the AJ&K Public Procurement Rules, 2017 and the rates shall be valid within 120 days from the award of contract.
