Notice Inviting E-Bidding

(Under single stage one stage E-Bidding System)

The Kotli Development Authority invites Electronics Bids in accordance with AJK PPRA Rules 36(a) single stage-one Envelope bidding procedure from the eligible firms /Contractors/Persons licensed by the Pakistan Engineering Council for the year 2023-24 and having endorsement in AJK PWD as well as Kotli Development Authority Kotli AK in appropriate category mentioned against each work in **Column 4, 5 below with relevant specialization code** for the following works. A Foreign Bidder is entitled to Participate in the Bidding only if having a joint venture with any Pakistani Construction Firm in accordance with relevant provisions of PEC by-Laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.


Bidding is open to all eligible Bidders:-

- Bidding is open to all Eligible Bidders/ Firms which are registered with C&W Department for E-bidding.
- Prospective bidding are required to get Username and Login details from IT section, office of Chief Engineer highways (North), Block11, DHQ Muzaffargarh. Bidders/ Firms which are already electronically registered with the department can use already provided user name and login.
- Bidding document and instructions to bidders can be downloaded prior to the specified opening date from C&W website (www.cwd.ajk.gov.pk).
- Interested bidder are required to submit their electronic bid up to **12:00 pm on 06-01-2024**, the bid will be open on **same day and same time** through E- bidding process and comparative statement will be visible to the participant bidders & bid opening committee for further process. The venue of E- bidding is at KDA Office Roli Hills housing Scheme Kotli.
- Scanned copy of bid security (CDR) must be uploaded , and hard copy of original bid security and bidding documents (signed and stamped) must be submitted in the office of the Executive Engineer Development Authority Kotli on the next day i.e on **08-01-2024** after opening of bid through E bidding system.
- Bidders who submitted their bids without a valid call deposit will be debarred from participating in bidding process for one year.
- The bid security of unsuccessful bidders will be returned upon awarded of contract to the successful bidder or on the expiry of the validity of bid, whichever is earlier.
- Electronic bidding shall be done on MRS (market rate system RWP) basis only two digits after the decimal point shall be considered for evaluation purpose.
- "Black listed firms / companies / suppliers / distributaries/ contractors / bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither blacklisted nor in conflict with government anywhere in territory of the state of AJ&K, federally administrated areas or Islamic Republic of Pakistan.
- Any bidder(s) bids provide incorrect information shall stand disqualified as per AJ&K-PPRA Rules.
- The competent authority reserves the rights to reject all the bids or any bid under clause 33 of AJK PPRA Rules.
