- 1. The firm should have valid registration with Pakistan Engineering Council for the year 2023/24
- The firm must be available in the active taxpayer list of the FBR/CBR.
- 3. The firm respective architect must be valid License holder of Pakistan Council of Architects and Town Planners (PCATP).
- 4. The firm shall solely apply on its own independent profile and not as Joint Venture (JV) agreement.
- 5. The nature of Ownership (Sole Proprietorship, Partnership or Firm/Company) with copy of memorandum and Article of association.
- 6. The selection of a firm will be bas on Quality Cost Based Selection method (QCBS) 70 % Technical 30 % Financial as per procedure/criteria described in the request for proposal (RFP) document.
- 7. The interested firms are required to submit sealed bids (comprising technical and financial proposals separately, clearly marked on the envelope as "Technical Proposal and Financial Proposal" for the services mentioned in the Request for Proposal (RFP), latest by March 19Th 2024 till 11:00 AM through post/registered courier services. The technical bids will be open on the same day at 11:30 AM in the presence of the bidders or their authorized representatives in Conference Hall of BAJK located at Gojra Bypass Muzaffarabad Azad Kashmir.
- 8. All bids must be accompanied by a Bid Security in the shape of Call Deposit from Bank of Azad Jammu & Kashmir or any other scheduled Bank of Pakistan (Not pay order), in the amount of **Rs.500,000/** in the name of Bank of Azad Jammu & Kashmir
