All bids must be accompanied by a Bid Security in the shape of Call Deposit from Bank of Azad Jammu & Kashmir or Bank of Pakistan (Not pay order), in the amount of **Rs. 160,000/-** on the name of Bank of Azad Jammu & Kashmir
