Local Government & Rural Development Department Go AJK under the project "Provision of Safe Drinking Water in AJK through Installation of Water Filtration Plants" donated by China under CPEC, invites sealed bids from interested and eligible bidders for "Installation of 150 Water Filtration Plants" in all districts of AJK as per following details:

- i. Bidders must be registered in PEC and have sufficient experience of handling of similar nature projects.
- ii. The bidder must have registration with FBR or AJK CBR and on active Tax Payer List (ATL) of FBR.
- iii. The bidding shall be under single stage two envelopes (containing two separate envelopes) procedure of AJK, PPRA rules. Each envelope shall contain separately the financial proposal and the technical proposal, the envelopes shall be marked as "TECHINICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHINICAL PROPOSAL" shall be opened; the envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened. Financial Bids will be opened later, on date which will be communicated to the successor bidder of technical bids only. Financial bid of non-qualified bidders will be returned unopened after evaluation of the Technical Bids.
- iv. The interested and eligible bidders can obtain Bidding Documents (including detail Terms and Conditions, BOQ, Drawings, Detail of Water Filtration Equipment and Specifications) on submission of written application against payment of Rs. 5000 (non-refundable) and other information in this regard from the Employer office during office hours before 24-02-2025.
- v. All interested bidders are advised in their own interest to carry out a comprehensive ground survey of project site/ work to be executed and filtration plants equipments stored in Rawalpindi Warehouse and accordingly submit well informed technical proposal with practical strategy in order to minimize the complication during implementation stage. Employer will not be responsible for any cost or expenses incurred on survey or field visit.
- vi. Pre bid meeting will be held for all interested bidders on 13-02-2025 at 11:00 am in Committee Room of Kashmir House Sector F-5/2, Islamabad.
- vii. All bids must be accompanied by a Bid Security as per detail mentioned above in the favour of "Director General Local Govt. & Rural Development Department Muzaffarabad" in shape of CDR, Pay Order or Bank Draft from any scheduled Bank of Pakistan.
- viii. All bids must be delivered to the address mentioned below before 12:00 pm on or before 25-02-2025. Technical Bids will be opened on same day at 12:30 pm for Lot-I, 12:45 pm for Lot-II and 01:00 pm for Lot-III in the presence of bidder's representatives who choose to attend the proceedings.
- ix. Black listed Firms/Companies/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with any Government department anywhere in territory of the State of AJK and in Pakistan.
- x. All taxes/duties applicable in AJ&K will be deducted from bills, as per prevailing rules.
- xi. Incomplete, conditional and without bid security bid shall not be entertained.
- xii. The employer reserves the right to reject any or all bids according to AJK, PPRA rules 33.
- xiii. Evaluation Report/Award of Contract shall be displayed on AJK, PPRA website (www.ajkppra.gov.pk).
