



Sealed bids are invited for procurement of **Emergency Procurement of Consumables for central Blood Transfusion services Muzaffarabad**, during the financial year 2025-26, which will be received up to 13 May, 2026 at 11:30 a.m. in the office of the Deputy Director Central Blood Transfusion Service, Muzaffarabad and will be opened on the same day at 12:00 p.m. in the presence of Bidders or their Authorized Representatives who choose to attend the meeting of bid opening.

- Bidding shall be contain through **Single Stage -One Envelopes bidding procedure** as per of AJK Public Procurement Rules 2017 (36A) shall be applied. The bid must comprise a single sealed envelope contain both Technical and Financial Proposal. The Procuring Agency shall evaluate the Technical proposal and reject any proposal which do not conform the specified requirements of bidding documents.
- Emergency Procurement of Consumables items for central Blood Transfusion services Muzaffarabad**, all manufactures/ authorized Importers and authorized distributors can participate.
- Bid Security (CDR) @ 60000/= (Sixty thousand Pak Rupees) of total bid value in the name of Deputy Director, AJK Central BTS/Regional Blood Center (RBC) Muzaffarabad must be accompanied with the Financial Bid and copy attached with Technical bid. Cheque shall not be accepted.
- Bids shall remain valid till 30th June 2026.
- A complete set of bidding document including detail specifications, quantity, terms & conditions can be obtained up to 1205-2026 on or before 02:00 P.M (Office hours) on submission of written application and upon payment of Rs. 1000/- (Rupees one thousand, non-refundable) in shape of cash or Bank Draft as bidding document fee in fever of **Deputy Director / Program Manager, AJK Central Blood Transfusion Service/Regional Blood Center Muzaffarabad situated at Abbas Institute of Medical Sciences (AIMS) Muzaffarabad , Azad Kashmir.**
- All taxes / duties levied by GoAJK will be charged from the bills under admissible rules.
- All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.
- The bidder shall submit an affidavit on legal stamp paper of Rs. 100/- that their firm has not been blacklisted in the past on any ground by any Government (Federal, Provincial and AJ&K), a local body or a public sector organization. On account of submission of false statement the bidder shall be disqualified forthwith and subsequently black listed.
- Tender notice will also be available on website of PPRA AJK (www.ajkppra.gov.pk). Bid evaluation report will also available on AJK PPRA website after approval from concerned authority.
