Bidders desirous to bid as Joint Venture must get prior approval from the Employer for bidding as Joint Venture.

**Bidding is open to all eligible Bidders:-**

1. The Newly registered bidders are directed to get user name and login details from **IT Section, office of Chief Engineer Highways (North) Block - H Muzaffarabad**. Bidders / Firms which are already registered with E-Bidding in the department can use user name and Password.
2. Bidding Documents and instructions to bidders are available on the dash board of E-Registered Bidder(s)/ Firms / on website <https://cwtenders.ajk.gov.pk>. Moreover, drawing can be obtained from office of the Executive Engineer PP&H Public Health Engineering Division-II Mirpur during office hours.
3. The Interested bidders are required to submit their Electronic Bid (**Technical & Financial**) up to due date & time mentioned in column 7 above. Technical Bids will be opened by E-Tendering System as per schedule i.e. **12:00 pm on 01-06-2026** as mentioned in column 7 above.
4. The Interested bidders must have to upload scan copy of call deposit showing proof of deposits of bid security mention in **column # 5** from any schedule bank of Pakistan having its branches in AJK or bank of AJK issued before uploading along with their relevant documents on its dash board.
5. The bidder must have Successfully completed at least 02 Project of similar nature during last five year.
6. The interested bidders shall upload their **Technical & Financial** Bids complete in all respects on E-Bidding Dashboard. Hard copy of Original Bank Receipts of Bid Security along with Technical Bids, Financial bids & Bidding Documents (uploaded by **PHE Division-II Mirpur**) duly signed & stamped by the Contractor/Firm must be submitted **in the office of the Executive Engineer PP&H PHE Division-II Mirpur AK** within **48 hours** after opening of Technical Bids through E-Bidding system. Otherwise such bidder / bidder(s) will be declared as disqualified.
7. The bid Securities of unsuccessful bidders will be returned through divisional cheque upon award of the contract to the successful bidder or on the expiry of validity of bid, whichever is earlier?

8. For the supply and installation of machinery the Firm has Eligible manufactures/supplier/Authorized dealer, registered with Pakistan Engineering Council (PEC) C-5 With specialized code **ME07/EE10** /Sales Tax and Income Tax Department GoAJK, FBR for the year 2025-26 can participate and submit Bid Rates in F.O.R **District Mirpur Tehsil Dadyal (Kashmir Colony)** basis including all Levy-able taxes duties applicable at the time of payment.
- i. For the machinery work only eligible bidders with following qualification should participate in the bidding process.
- a. Has completed at least one contract of similar nature of work with a value of 20-30 Million during last 03 years
- b. All others terms/conditions mentioned in the bidding documents shall be fulfilled.
- ii. The Bid must be accompanied by a declaration/affidavit that he or its firm is not black listed by any of the departments/ ministries and it must also state the names of the works with costs, if any allotted to him which are still under execution Bidding documents will not accepted without this declaration/affidavit.
- iii. Warranty will be claimed as per manufacture security and signed Contract Agreement.
- iv. The purchase committee reserved the right to accept or reject the Bids according to **Rules-33 of AJKPPRA 2017** accordingly.
- v. Drawing Design and any other information can be collected from the office of **Executive Engineer PWD PHE Division-II Mirpur** during office hours.(Ph#05827-922678).
- vi. The Bidders must visit all the sites where machinery is to be installed before the submission of bids.
- vii. The Bidders must provide the Certification of his registration as the manufacture for the items to be supplied/ installed at site.
- viii. The bidders are requested to give their best final price as no negotiations are expected.
- ix. Pre-Delivery inspection will be carried out by Nominated Purchase Committee before Supply of the items/ machinery of Supplier at his own firm expenses shall be provided with the proposals/bids.
- x. Complete specification technical data brochures shall be provided with the proposals/bids.
9. Electronic bidding shall be done on Percentage (**above/below/At Par**) basis on market and prevailing “**MRS, 1<sup>st</sup> BI-ANNUAL-2026 (01.01.2026 to 30.06.2026) DISTRICT JHELUM**”. Bidder have to quote only two digits after the decimal point shall be considered for evaluation purposes.
10. Black listed firms / Contractors / Companies are not allowed to participate in the bidding process. The Interested bidders shall furnish an affidavit / Certificate that they are neither black listed nor involved in conflict with government any where in territory of state of AJK or federally administrated areas / all provinces of Islamic Republic of Pakistan.
11. In E-Bidding System the software supports only PDF file format for Technical profile uploading option, therefore interested bidder shall upload their technical Bid in PDF file Format only.
12. Any Bidder(s) who provides incorrect information or does not submit hard copies of Technical, Financial & Bid Security uploaded on its Dash Board along with complete bidding documents with in 48 Hrs in the office of the undersigned after technical bid opening shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
13. Pre Bid meeting will be held on **01-06-2026 at 01:30PM in the office of the Executive Engineer PP&H PHE Division-II Mirpur AK**.
14. Other terms & conditions are available in the bidding documents.
15. The Competent authority reserve the rights to reject all or any bid under the **clause 33 of AJK PPRA Rules**
