

INVITATION FOR E-BIDDING

(Under Single Stage Two Envelop E-Bidding System)

Azad Jammu & Kashmir Power Development Organization, invites electronic bids in accordance with AJK PPRA Rules 36(b) as per single stage Two envelop bidding procedure from the eligible firms / Contractors licensed by the Pakistan Engineering Council (PEC) in the appropriate category, with specialization codes as mentioned in **column # 4** below. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provision of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval from the Employer for bidding as Joint Venture.

- The Newly registered bidders are directed to get user name and login details from IT Section, office of **Chief Engineer Highways Muzaffarabad**. Bidders / Firms which are already registered with E-Bidding in the department can use already provided user name and Password.
- Bidding Documents and instructions to bidders are available on the dash board of E-Registered Bidder(s)/ Firms / on website <https://cwtenders.ajk.gov.pk>.
- The Interested bidders are required to submit their Electronic Bid (Technical & Financial) up to due date & time mentioned in column 6 above. Technical Bids will be opened by E-Tendering System as per schedule i.e. **01:30 pm** on **02.06.2026** as mentioned in column 6 above.
- The Interested bidders must upload scan copy of call deposit or receipt of cash deposit showing proof of deposits of bid security as mentioned in **column # 5** in favor of undersigned from any schedule bank of Pakistan having its branches in AJK or Bank of AJK along with their relevant documents on its dash board.

- In case Contractor's total quoted bid price is less than **10% below** of Estimated Cost the bidder shall submit additional bid security equal to the difference between Estimated Cost and total quoted Bid price in the form of CDR or cash deposit in the Account as mentioned at Serial No 4 (i ,ii) above and shall upload scanned copy of Bank Receipt on its Dashboard. Bids not carrying the Additional Bid security shall be rejected.
- If the two or more Contractors/firms become the lowest in financial evaluation by quoting the same total bid price, the decision of the procuring agency to accept the tender for award on the basis of specific experience will be final.
- The bid Securities of unsuccessful bidders will be returned through cheque upon award of the contract to the successful bidder or on the expiry of validity of bid, whichever is earlier.
- The interested bidders shall upload their Technical & Financial Bid complete in all respects on E-Bidding Dashboard. Hard copy of Original Bank Receipts of Bid Security along with Technical Bids, Financial bids &

Bidding Documents (uploaded by AJK PDO) duly signed & stamped by the Contractor/Firm must be submitted in the office of the Dy. Director Civil Power Development Organization Muzaffarabad within 48 hours after opening of Technical Bids through E-Bidding system. Otherwise such bidder / bidder(s) will be declared as disqualified.

9. Electronic bidding shall be done on Percentage (above/below) basis on market and prevailing "MRS, 1st BI-ANNUAL-2026 (01.01.2026 to 30.06.2026) DISTRICT MURREE. Bidders have to quote only two digits after the decimal point shall be considered for evaluation purposes.
10. Black listed firms / Contractors / Companies are not allowed to participate in the bidding process. The Interested bidders shall furnish an affidavit / Certificate that they are neither black listed nor involved in conflict with government anywhere in territory of state of AJK and Federally Administrated Areas / all Provinces of Islamic Republic of Pakistan.
11. In E-Bidding System the software supports only PDF file format for Technical profile uploading option, therefore interested bidder shall upload their technical Bid in PDF file Format only.
12. Any Bidder(s) who provides incorrect information, Fake or Forge documents shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
13. Pre-Bid meeting will be held on **22.05.2026 at 10:00 am** in the office of the **Dy. Director Civil Power Development Organization Upper Chatter Muzaffarabad AJK.**
14. Other terms & conditions are available in the bidding documents.
15. The procuring agency reserves the rights to reject all or any bid under the **clause 33 of AJK PPRA Rules.**
16. In case e-Bid or proposal including record submitted on the E-Tendering Dashboard found corrupt, un-readable or contain virus, the e-bid or proposal shall be rejected.
17. In case of joint venture, the maximum number of firms shall be two.
